Importing Goods to Ireland



Importing Personal Effects

As a general rule, the Irish Customs authorities grant duty free entry for used household goods and personal effects provided that you have owned and used them for at least 6 months prior to your relocation.

You will be required to prove that you have applied for residency prior to your goods' arrival in Ireland.

You may also need to provide proof that you have lived in your origin country for at least 12 months prior to moving to Ireland.

Documentation

Britannia will assist you to complete the customs formalities. To help us with this we will need a copy of your passport (and visa if applicable).

Our team members will supply you with the appropriate import documentation before the arrival of your goods which you must complete to facilitate clearance. To avoid additional charges it is essential that documentation is completed and returned promptly.



Prohibitions and Restrictions

The following items are prohibited or restricted and we strongly advise you not to ship them in your consignment:

- · Firearms, ammunition & weapons
- · Inflammable goods & substances
- · Plants, plant material & animal products
- · Foodstuffs, perishables or otherwise
- · Alcohol, tobacco & narcotics
- · Objectionable and indecent material
- Endangered species

If a vehicle is stopped and searched and these are found amongst household effects, there are large fines plus the costs of delays to the vehicle and costs to any third parties who are thus also affected.

Transit Times

Transit times can vary subject to the method of transport chosen, size of your consignment for part or dedicated load, and where you are moving to. Britannia will advise you on the predicted arrival dates once this information is established.

Motor Vehicles

Importation of motor vehicles to Ireland may be duty free providing the vehicle has been owned and used for more than 6 months prior to shipment to Ireland, and will not be sold or otherwise disposed of for one year after the date of importation. Motor vehicles may only be imported when you have arrived in Ireland.

Ireland has always been a popular destination for people looking to move overseas. For many years Britannia has been providing a regular removal service between the UK and Ireland, and can offer a door to door service if required.

Storage

Should you require storage prior to delivery, this can be arranged on your behalf. You should expect to pay a one-off storage handling fee plus a monthly storage charge. Please note that these charges are payable locally. It is important that you ensure that your marine insurance policy is extended for the period of the storage.

Destination Services

If you have selected a full door to door service, Britannia will deliver the goods to your new home and your furniture and boxes will be placed in the relevant rooms. All furniture will be unwrapped and cartons packed by Britannia will be unpacked on to a flat surface. All used packing materials will be removed from site on the delivery day.

Although there will be insurance implications, you retain the right not to have some or all items unpacked should you choose.

Alternative destination services may also be available, but are subject to your final destination and the chosen method of transport. Your Britannia representative can advise you of the options available.
